#### RIVERSIDE TOWNSHIP DISTRICT GOALS UPDATE

Ms. Ehrich updated the progress toward the 2016-2017 district goals:

**Goal #1**: In the 2016-17 school year the Board of Education will hire a part-time Curriculum Coordinator. She will facilitate updating our curriculum and through meaningful sustained professional development, assist teachers in applying and implementing the NJ Learning Standards within daily instruction.

We are seeking BOE approval of the US History II curriculum this evening. The ELA K-5 framework has been completed and is currently being formatted with our learning resources. The K-5 Math framework has also been completed. Learning resource still to come.

Working on Math 6-8, Alg I, II and Geometry curricula.

On the science front staff and administration from the ES and MS recently visited the Mt. Holly School District to view their Next Generation Science Program in action. All agreed this was a highly productive endeavor.

The Curriculum Coordinators from Riverside and Delanco are getting ready to review and compare the Spanish 6-8 curriculums to ensure consistency of program going into the high school experience.

ESL PD going very well as we have one of our teachers participating in a yearlong teaching and learning program through Stockton University. Interestingly a former ESL teacher here Dr. Lois Spitzer wrote the grant and when we reached out to her she gladly opened a spot for Mrs. Perez-Wilchacky to attend.

Elementary teacher Shari Tishgart will be trained in Wilson Reading this year. On March 15<sup>th</sup> State BOE will approve Professional Standards for School Leaders. Dr. Szymanski will turn key this to the administrative team. Our five courses in the CAP program will be scrutinized because RCBC is going through a Middle States evaluation. PLC groups in the HS are currently reviewing writing standards and formative assessments.

The director has submitted a youth literacy grant through the Crayola Corporation which would allow us to purchase a Wilson Fundations Program for the ES. She has also arranged to have the Alice Paul Institute provide a free student assembly for middle school students.

**Goal #2:** Through the middle school Climate committee we will seek to improve middle school attendance and tardy numbers. We will reduce both absences and tardiness by 5% over 2015-16 final numbers respectively. Absences: 2,769, goal <2,630 and Tardy: 2,245, goal < 2,132.

The school climate committee has been established and is meeting on a regular basis. Two families were remanded to an appearance before Judge McInerney in January. The middle school administration has attended court ordered mediation with eleven parents and their children in February. The overall number of absences has decreased by 2.4% to date. The number of tardies has decreased by 3.6% to date. All students with no absences and tardies in the 2<sup>nd</sup> marking period were entered into a drawing for a 25.00 Target gift card.

The targeted intervention continues with guidance counselor intervention, teacher to student mentoring and parent conferencing with administration and guidance.

Goal #3: By June 2017 the BOE will approve eight (8) updated job descriptions.

After this evening's meeting we will have approved four job descriptions (Curriculum Coordinator, Sports Night Association Treasurer, Preschool and Basic Skills Aides). As a courtesy the REA has been consulted on all job descriptions. We are halfway to our goal.
