GOOD NEWS

Mrs. Milch reported that the Riverside Township Board of Education was awarded \$5,000 from the BCIP JIF, Burlington County Insurance Pool Joint Insurance Fund, as follows: \$2,500 for Elite II Safety Incentive reward, \$1,500 for Financial Performance Award for Maintaining a 10-Year Average Loss Ratio below 50% and \$1,000 for maintaining a current Loss Ratio below 50%. (Total \$5,000) This is a direct reflection of providing a safe and healthful environment for our schools. We are rewarded for managing our risk and this usually results in lower premiums. In addition, teacher and Coach Chris McManus attended and was recognized as a *Safety Star* for his heroic action on the field as a first responder for a sophomore soccer player who suffered a medical emergency in September. The Riverside Township Board of Education was rewarded \$750 from the Lance Group for participating in the Shape Up program and having the second highest percentage of participation out of all the school districts. This has brought our total rewards up to \$6,250 since inception of the program. The school play, *The Addams Family*, will be performed on January 27 and January 28 at 7 p.m. Senior Kevin Rae was named to the 2016 Burlington County All Academic First Team for football and Senior Brynn McCall was awarded the Dr. Ron Goldberg scholarship award for \$350 from the Field Hockey Club of South Jersey. After shadowing an oncologist last summer, she entered competition by writing an essay on her career choice.
