#### SUPERINTENDENT'S REPORT

Ms. Ehrich gave the Final Report of Progress Toward District Goals:

Goal #1: In the 2016-17 school year the Board of Education will hire a part-time Curriculum Coordinator. She will facilitate updating our curriculum and through meaningful sustained professional development, assist teachers in applying and implementing the NJ Learning Standards within daily instruction.

In the current school year we approved the following curriculum: Social Studies PK-5, Social Studies 6-8, US History II, and Math K-5. Tonight we are approving ELA K-5 and Science K-8 curriculum.

We continue our work on Math 6-8, Algebra I, II and Geometry.

This is a tremendous amount of curriculum writing/rewriting in a single school year. I thank Dr. Szymanski for her leadership in this endeavor as well as the administrative team and our teachers for their hard work in supporting completion of this goal.

Goal #2: Through the middle school Climate committee we will seek to improve middle school attendance and tardy numbers. We will reduce both absences and tardiness by 5% over 2015-16 final numbers respectively. Absences: 2,769, goal <2,630 and Tardy: 2,245, goal < 2,132.

Two families were remanded to an appearance before Judge McInerney in March and April. A third appearance for both families is scheduled for the end of the month. The middle school administration attended court ordered mediation with five parents and their children in the month of April. The final data reflects accomplishing our goal of reducing absences and tardiness to school. Absences were reduced by 5.8% (2,769 to 2,609) and reduced lateness to school by 41% (2,245 to 1,324). Thank you to Mr. Mongon, his middle school staff, our students and parents for a job well done.

# Goal #3: By June 2017 the BOE will approve eight (8) updated job descriptions.

This goal has been met per our April update
