DISTRICT GOALS

Ms. Ehrich gave an update on the district goals:

Goal #1: In the 2016-17 school year the Board of Education will hire a part-time Curriculum Coordinator. She will facilitate updating our curriculum and through meaningful sustained professional development, assist teachers in applying and implementing the NJ Learning Standards within daily instruction.

The process of aligning our ELA and mathematics curriculum to the Curricular Frameworks and new Student Learning Standards by September 2017 has begun. Dr. Szymanski has developed a pre-work template which she and elementary teachers have been using as a means to document our instruction and learning resources. The pre-k through grade five Social Studies curricula has been updated and BOE approved. Dr. Szymanski is currently working with the middle school staff to update the 6-8 SS curriculum. On the professional development front teachers have attended workshops on balanced literacy (Delanco and Medford); visits are set up in Mt. Holly (K-2, 3-5 and 6-8 buildings) for ES and MS administration and select teachers to view Next Generation Science Standards and in the 8th grade an investigation into the STEM course being taught to advanced students. Other workshops focusing on identifying struggling readers, behavior management and writing have been attended. We are also taking advantage of collaborative PD opportunities with the Delanco School District. Dr. Szymanski is also participating in grade level and PLC meetings in all three schools. ES and MS administrators are attending the December BCCC meeting where they will observe a guided reading lesson with a feedback exercise which will be turn keyed to staff. This is an exercise focusing on the observation and what our principals will be looking for in a formal observation. In the coming months we will be assessing the middle school math program.

Goal #2: Through the middle school Climate committee we will seek to improve middle school attendance and tardy numbers. We will reduce both absences and tardiness by 5% over 2015-16 final numbers respectively. Absences: 2,769, goal <2,630 and Tardy: 2,245, goal < 2,132.

The school climate committee has been established and is meeting on a regular basis. The MS is holding their first annual turkey trot on Wednesday, Nov. 23. At the end of the event students with no absences or tardies in the first marking period will be entered into a drawing to win a 25.00 gift card. Tips and resources for parents have been placed on the MS website. Homerooms have been established based on first period class assignments in all but three classes in order to eliminate the transition period between homeroom and first period of the day. Parents are sent letters inviting them in for attendance conferencing beginning with the fourth unexcused absence. The middle school administration has attended court ordered mediation with five parents and their children to date.

Goal #3: By June 2017 the BOE will approve eight (8) updated job descriptions.

Two job descriptions have been approved. The job description for the new curriculum coordinator was created over the summer and was BOE approved. The Sports Night Association Treasurer job description has been updated and BOE approved. As a courtesy the REA has been consulted on all edits.
